



## The Children's Institute of Hong Kong Approved Coursework Provider

### *Program Overview*

The applied behavior analysis special instruction graduate-level certificate program is an advanced-teacher or therapist preparation program that focuses on the application of behavior analysis and behavioral principles to address the needs of students with special needs, general education students, and other types of learners. It is unique and the only one of its kind in Hong Kong. Our program meets the educational requirements to sit for the Behavior Analyst Certification Board Inc. ([BACB](#)) examination or Qualified Behavior Analyst ([QABA](#)).

Individuals who hold an undergraduate or graduate degree in special education, psychology, or a related field, and who are seeking certification through the Behavior Analysis Certification Board, Inc. (BACB) as a BCaBA may start their journey through enrolment in this Approved Four-Course Sequence aimed at preparing students for the BACB examination or QABA examination. ## *Program Requirements*

The minimum requirements for registration of the four (4) (BCaBA/QASP-S) course sequence are indicated below.

1. Degree: Possession of a minimum of a bachelor's (BCaBA/QASP-S) that was conferred in behavior analysis or other natural science, education, human services, engineering, medicine or a field related to behavior analysis and approved by the BACB, Inc. or QABA  
*Please Submit official transcripts.*
2. Resume/Curriculum Vitae: Submission of an updated resume/ CV.
3. References: Submission of two (2) written and signed professional references. Personal references will not be accepted.
4. Registration Fee: Submission of \$5000 *non-refundable* fee
5. Tuition: Tuition payments are required in full prior to the start of each class.

Each of the four classes is \$7399.00 payable in Hong Kong Dollars.

## *Program Schedule*

### Four-Course Sequence of Classes

BA 801	Introduction to Applied Behavior Analysis in Special Education <sup>1</sup>
BA 802	Measurement & Experimental Analysis with Single Case Experimental Design
BA 803	Behavior Change Strategies & Tactics
BA 804	Advanced Techniques in Verbal Behavior & Behavioral Research

*Coursework: The applicant must complete 180 classroom hours of undergraduate- or graduate-level instruction in the following content areas and for the number of hours specified:*

A. Ethical and Professional Conduct – 15 hours

The content should be based on the BACB Professional Disciplinary and Ethical Standards and the BACB Guidelines for Responsible Conduct for Behavior Analysts.

B. Concepts and Principles of Behavior Analysis– 45hours

The content should be based on the BACB Foundational Knowledge List.

C. Research Methods in Behavior Analysis

The content should be based on the BACB Fourth Edition Task List.

- Measurement (including Data Analysis) – 10 hrs
- Experimental Design – 5 hrs

D. Applied Behavior Analysis

The content should be based on the BACB Fourth Edition Task List.

- Fundamental Elements of Behavior Change & Specific Behavior Change Procedures – 45 hrs
- Identification of the Problem & Assessment – 30 hrs
- Intervention & Behavior Change Considerations – 5 hrs
- Behavior Change Systems – 5 hrs
- Implementation, Management and Supervision – 5 hrs

E. Discretionary – 15 hours

*Each course is presented in three-hour blocks once per week for 15 weeks (45 credit hours)*

*The total credit hours combined across all four classes is 180. The expected total course sequence from start to finish is four semesters or two years. Supervision Experience is also required (separately).*

*Coursework: The applicant must complete 270 classroom hours of undergraduate- or graduate-level instruction in the following content areas and for the number of hours specified:*

A. Ethical and Professional Conduct – 45 hours

The content should be based on the BACB Professional Disciplinary and Ethical Standards and the BACB Guidelines for Responsible Conduct for Behavior Analysts, i.e. “The Code”.

B. Concepts and Principles of Behavior Analysis– 45hours

The content should be based on the BACB Foundational Knowledge List.

C. Research Methods in Behavior Analysis

The content should be based on the BACB Fourth Edition Task List.

- Measurement (including Data Analysis) – 25 hrs
- Experimental Design – 20 hrs

D. Applied Behavior Analysis

The content should be based on the BACB Fourth Edition Task List.

- Fundamental Elements of Behavior Change & Specific Behavior Change Procedures – 45 hrs
- Identification of the Problem & Assessment – 30 hrs
- Intervention & Behavior Change Considerations – 10 hrs
- Behavior Change Systems – 10 hrs

- Implementation, Management and Supervision – 10 hrs

E. Discretionary – 30 hours

*Each course is presented in three-hour blocks once per week for 15-16 weeks (44-46 credit hours)*

*The total credit hours combined across all four classes is 270. The expected total course sequence from start to finish is four semesters or two years. Supervision Experience is also required (separately).*

### *Program Instructors*

BA 801 (Tuesdays) , 802 (Tuesdays or Thursdays), & 803 (Thursdays) are taught in traditional live face to face classes at The Harbour School Grove Campus in Ap Lei Chau. These may be attended online as well. Each class is one semester and students can take more than one class per semester. BA 807, 808, & 809 classes are all taught online.
